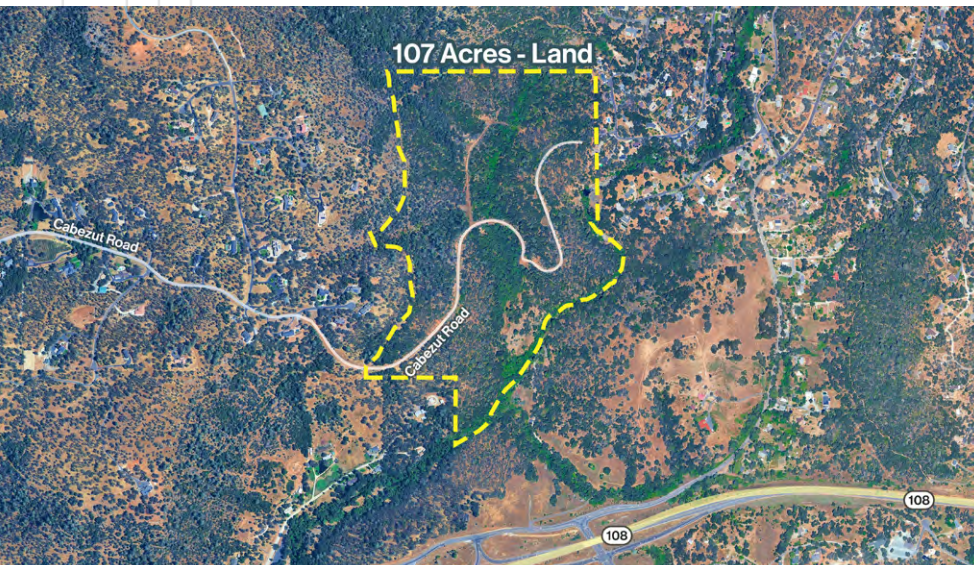

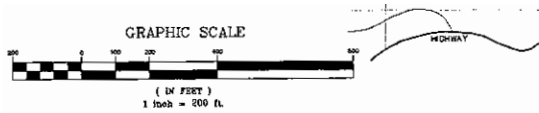

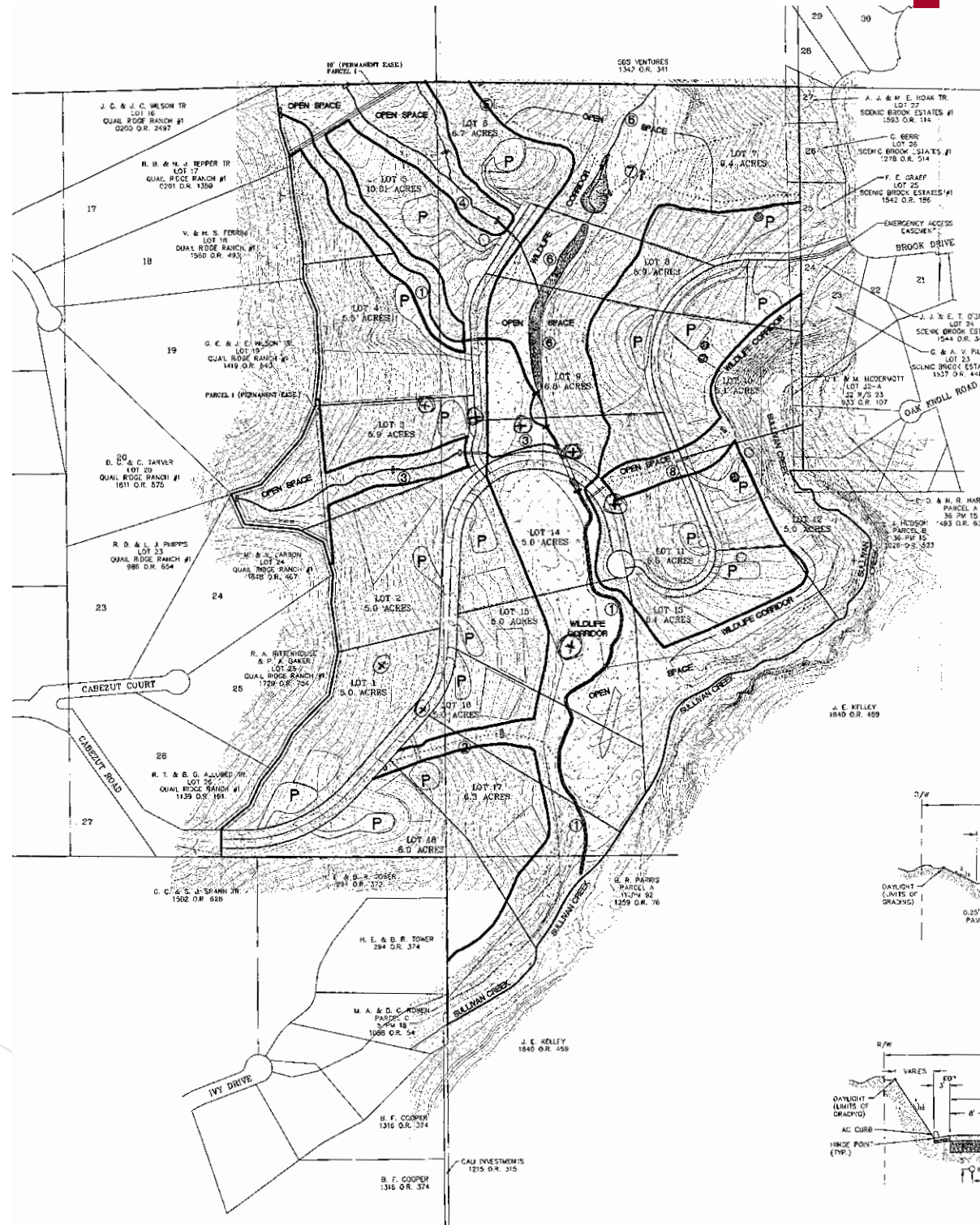
Tentative Map
